Sandoz re-introduces generic version of Bactocill® injection in ADD-Vantage® vials

Princeton, New Jersey; March 20, 2008 -- Sandoz today announced the re-introduction of oxacillin sodium injection, a generic equivalent of Bactocill® in ADD-Vantage vials®, in the United States. Sandoz is marketing oxacillin sodium injection in ADD-Vantage vials of 1 gram base and 2 gram base strengths.

The ADD-Vantage design keeps the drug and diluent separate until the system is activated just prior to administration. Oxacillin sodium injection is used to treat a wide variety of bacterial infections.
